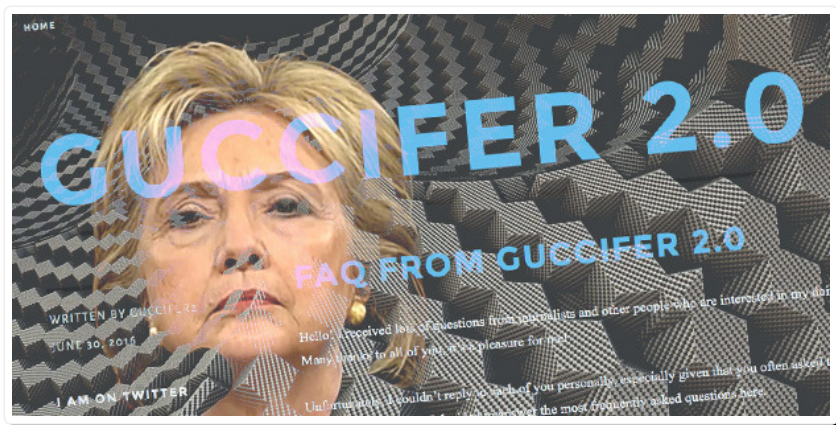


FIG. 1—HILLARY CLINTON FOUNDATION CORRUPTION EXPOSED BY GUCCIFER.

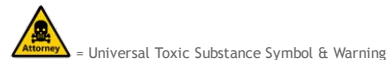
