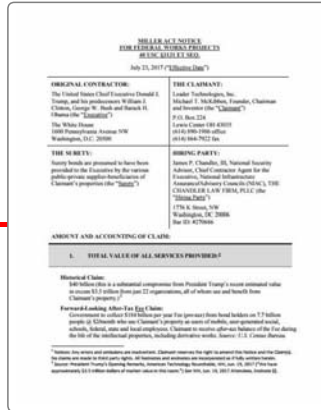


FIG. 2—Miller Act Notice of Leader Technologies and inventor Michael McKibben filed at the White House on July 23, 2017. They demand full compensation for the federal government’s wholesale theft of their social networking inventions thru a broad, “free” distribution to its military-industrial spying and profit-making insiders. The government used the freshly-minted [IBM Eclipse Foundation](#) formed with a \$40 million IBM “donation” just four (4) weeks after The Patriot Act was signed into law.

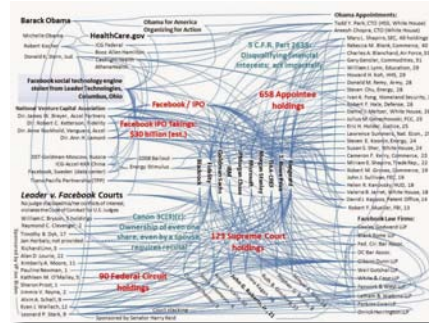

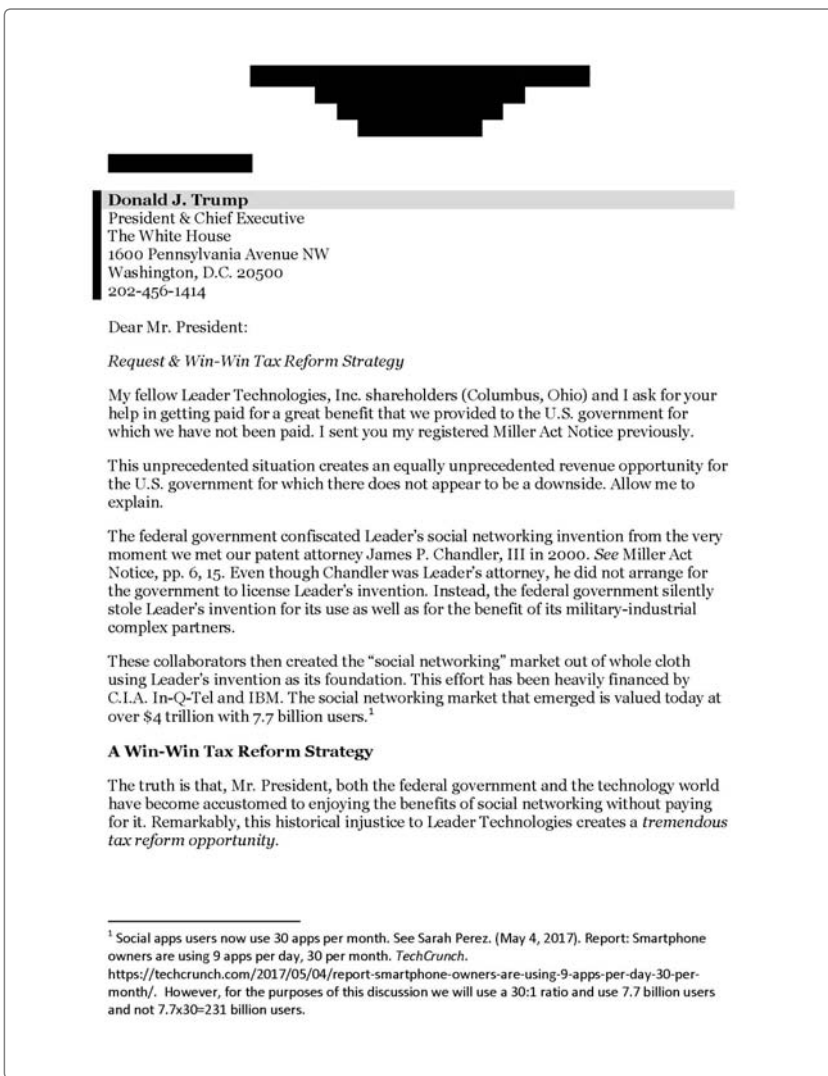


FIG. 2 – [Cover letter to President Donald Trump from many hundreds of Leader shareholders across America](#) beginning to send Tier II Miller Act Notices to the White House asking the federal government to finally pay them for using their social networking invention for the last 17 year, since 2000 when Clinton national security advisor James P. Chandler, III first learned of Leader's innovation. See [previous post](#).

government's benefit, and (2) a \$2 per user per month "Leader Innovation Surcharge" to pay Leader for the ongoing use of its inventions.

By comparison, computer users pay anywhere from \$2.00-\$5.00 per month for anti-virus software. So, Leader's request is very reasonable value-wise.

[TechCrunch](#) recently said that 30 apps a month on average are used per person. There are 7.7 billion people on the planet with potential access to social apps. If 3 billion people have access to social networking, that would represent 90 billion apps per month.

Using 7.7 billion user-licenses as a benchmark, the government in this example would receive \$23.1 billion per month or \$277 billion per year in Consumer Use Fees.

These Consumer Use Fees could fund the wall, subsidize a high risk healthcare pool, and other such social priorities—all without relying on income tax.

At the same time, using the same 7.7 billion user-licenses example, Leader shareholders can finally be paid \$2/user/month or \$185 billion per year for the ongoing use of their important inventions.

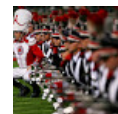

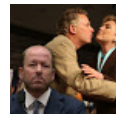

Edmonton Police Chief Rod Knecht said the driver, believed to be 30 years old, then got out and attacked the officer with a knife before fleeing on foot.

Judge Rader also failed to disclose his conflicting relationships with a Leader principle with whom he may have had deep professional differences during his time at the Senate Judiciary Committee—his former professor of law at George Washington University Law Center, former Leader director Professor James P. Chandler. [See analysis of Judge Rader's undisclosed conflicts of interest in *Leader v. Facebook*.](#) Judge Rader also did not stop his judges from creating new arguments and evidence for Facebook in the secrecy of chambers—after they had debunked all of Facebook's evidence on appeal, which is a clear breach of constitutional due process.

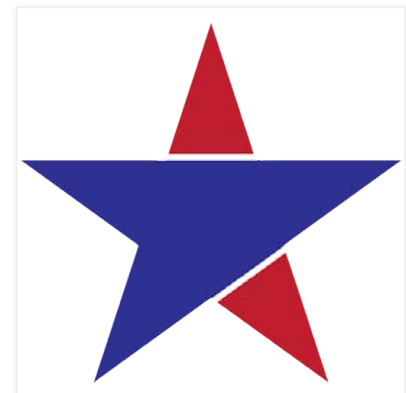

The Pew Research Center looked at media reports about the Trump presidency in the first three months of the administration and concluded:

-62 percent of the stories had a negative assessment, with just 5 percent having a positive assessment.

-20 percent of the stories in President Barack Obama's first three months were negative.

-28 percent of the stories in President George W. Bush's first three months were negative.

-28 percent of the stories in President Bill Clinton's first three months were negative.

-56 percent of stories about the Trump administration appearing in media outlets with a left-leaning audience were negative, compared to 14 percent in media outlets with a right-leaning audience.

-66 percent of all news stories regarding the Trump administration were about these five topics:

- Political skills (17 percent).
- Immigration (14 percent).
- Appointments/nominations (13 percent).
- U.S.-Russia relations (13 percent).
- and healthcare (9 percent).

Other studies have come up with similar results, including a Media Research Center study that concluded the three major broadcast networks' coverage of the Trump administration was 89 percent negative.

Another study found the coverage of the Trump White House was 91 percent negative over the summer on nightly news broadcasts.

"Project MKUltra" was the name given to an illegal program of human experimentation conducted by the US Central Intelligence Agency, which investigated mind control. The 1975 Church Committee hearings exposed the operation - and on July 20, 1977 a Freedom of Information Act request uncovered a cache of 20,000 documents relating to it.

The origins of MKUltra lie in 1945, and Operation Paperclip - the secret transfer of top Nazi scientists to the US. Armed with extensive documentation on unethical Nazi human experimentation, including research into mind control, a clutch of military programs related to mental manipulation and behavioral modification were launched - including Projects CHATTER, BLUEBIRD and ARTICHOKE.

Headed by former chemist Dr. Sidney Gottlieb, MKUltra began in April 1953 on the orders of then-CIA Director Allen Welsh Dulles.

Officially - albeit behind closed doors - the CIA claimed the program was pursued in response to perceived instances of mind control techniques employed by Chinese, North Korean and Soviet forces on Allied prisoners of war in the Korean War.

In truth, the agency wished to produce an optimal truth drug for use in interrogations, and explore possible uses for mind controlled subjects - including the control of foreign leaders, and assassination.

Mueller's all-star team of prosecutors, with expertise in money laundering and foreign bribery, has an answer to that. He's Michael Dreeben, a bookish career government lawyer with more than 100 Supreme Court appearances under his belt.

Acting as Mueller's top legal counsel, Dreeben has been researching past pardons and determining what, if any, limits exist, according to a person familiar with the matter. Dreeben's broader brief is to make sure the special counsel's prosecutorial moves are legally airtight. That could include anything from strategizing on novel interpretations of criminal law to making sure the recent search warrant on ex-campaign adviser Paul Manafort's home would stand up to an appeal.

On my test systems, the new app appeared as part of Windows updates delivered on October 10. Based on ratings and reviews in the Store, other Windows 10 users saw the update as early as October 1.

More than 70 percent of the early reviews have given the mystery add-on a 1 star rating, with reviewers adding comments like these:

Installed without permission:

I didn't ask for this, I didn't approve this, I didn't even know you were planning on installing this. When will you get it that people don't want YOU to decide what gets installed on MY computer. Stop it already.

Forced install:

Not cool, MS.

Don't install without asking:

I have no idea what this even does. Why do I have it and why didn't I have a choice?

So, what is the mystery app? The answer turns out to be relatively innocuous.

It is indeed an update for the built-in Photos app, included with every copy of Windows 10. Its official name is Photos.DLC.Main (DLC apparently stands for "downloadable content"), and it's listed in Settings > Apps > Apps & Features. Find the Photos app, click Advanced Options, and look under the App Add-ons & Downloadable Content heading: . . .

Let us take stock of how the private companies that manage two of the largest communication platforms in the world—Facebook and Twitter—have managed people's speech in the last week alone:

Rapper Lil B was temporarily banned from Facebook for "hate speech" after calling out gun-loving white people (calling them "violent") in the wake of a deadly shooting in Las Vegas committed by a white retiree; actress Rose McGowan was briefly suspended from Twitter after speaking out about those who enabled her own abuse at the hands of Harvey Weinstein; and Twitter first blocked but then allowed US congresswoman Marsha Blackburn to run an ad promoting a far-right conspiracy theory about Planned Parenthood selling baby body parts, which has been thoroughly debunked.

Add this all to the ongoing trainwreck regarding possible election interference on Facebook (a byproduct of the company running ads from essentially anyone who can pay and relying largely on user reports to weed out the bad), and it's very clear that there is a serious problem with how private corporations manage public speech. Namely, the corporations in charge of the largest speech platforms on Earth have utterly failed to manage speech on those platforms, and increasingly seem incapable of doing so.
