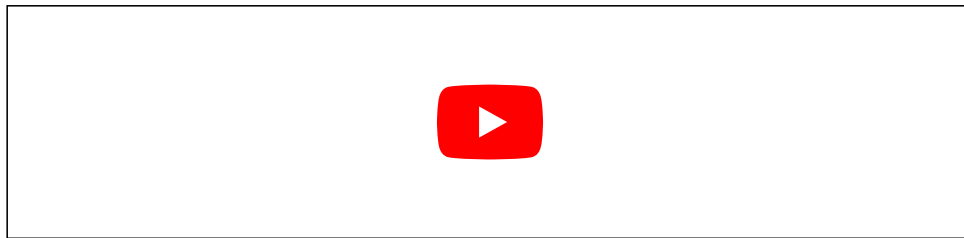

Michigan's Secretary of State Jocelyn Benson committed fraud by contracting with a Dominion foreign profit Colorado corporation branch with *no authority to operate in Michigan*.

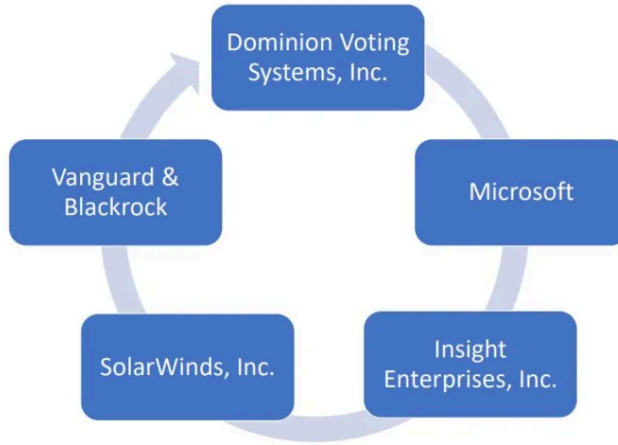
