


Fig. 2—The ultimate controller of the U.S. Federal Reserve is The City of London, which is controlled by the British Crown via the Pilgrims Society.




Fig. 3—Comedian George Carlin (1937-2008). “It’s a big club, and you ain’t in it . . . It’s called the American Dream because you have to be asleep to believe it.” Nov. 05, 2005, Beacon Theater, New York City, New York.








Fig. 8—[Jamie Dimon. \(May 24, 2023\)](#). Biography and Timeline. Anonymous Patriots.

Just like John Pierpont ("J.P.") Morgan Sr. (son) and Junius Spencer ("J.S.") Morgan (father) before him, their JPMorgan Chase Bank rolls up to the Rothschilds who have dictated the banking business of The City of London since ca. 1760 to finance German Hessians to fight along the Red Coats against the American Continental Army.

## CURRENT EDITORIAL FOCUS

We are an opinion blog that advocates for strong intellectual property rights. We welcome commenters and contributors. The *Leader v. Facebook* patent infringement case first came to our attention after learning that the trial judge, Leonard P. Stark, U.S. District Court of Delaware, ignored his jury's admission that they had no evidence to support their on-sale bar verdict, but the judge supported it anyway.

The judicial misconduct has deteriorated from there, replete with two of the three judges on the Federal Circuit appeal panel, Judges Alan D. Lourie and Kimberly A. Moore, holding Facebook stock that they did not disclose to the litigants, and later tried to excuse through a quick motion slipped in at the last minute by the Clerk of Court, Jan Horbaly, and his close friends at The Federal Circuit Bar Association. (The DC Bar subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)

The judges ignored [shocking new evidence](#) that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from *Leader Technologies* that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on *Leader v. Facebook* until justice is served, but we also welcome news and analysis of intellectual property abuse in other cases as well.

These “pilgrims“ are not American Plymouth pilgrims, or Christian, or Jewish, or Muslim.

Instead, they are 4000-yr. old pagan merchant-banking pilgrims from Babylon called “Radhanites” or “Radknights” who literally worship demons like Mammon, Lucifer, Lilith, Azmodeus, Ba’al, Beelzebub, and Moloch.



Smyrna was renamed İzmir, Turkey in 1930.






Fig. 11—Charles Jocelyn Hambro, head of [Special Operations Executive \(SOE\)](#) (SOE, 1942 May to 1943 Sep., absorbed SIS (Secret Intelligence Service)—[Stay-Behind Networks](#) (global spies) later run by MI6-C.I.A. after WWII; later [Office of Strategic Services \(OSS\)](#); later Central Intelligence Agency (C.I.A.)


