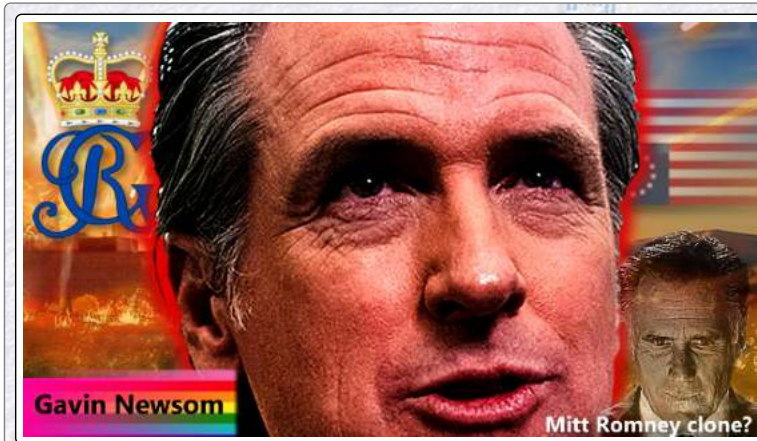


Fig. 1—Gavin Christopher Newsom. Born Oct. 10, 1967, San Francisco. That's about it for a real biography of achievements. The rest is the story of a Jesuit-programmed child, then turned over to the Gettys and their handlers—the British Pilgrims Society—to push forward as their adult automaton, just like they are doing with Ron DeSantis, Candace Owens, Charlie Kirk, Glenn Youngkin, Kamala Harris, Nikki Haley, Vivek Ramaswamy, Pete Buttigeig, Mike Pompeo, Gretchen Whitmer, Katie Hobbs, Mike Pence, John Roberts, Brian Kemp, Ketanji Jackson, etc.

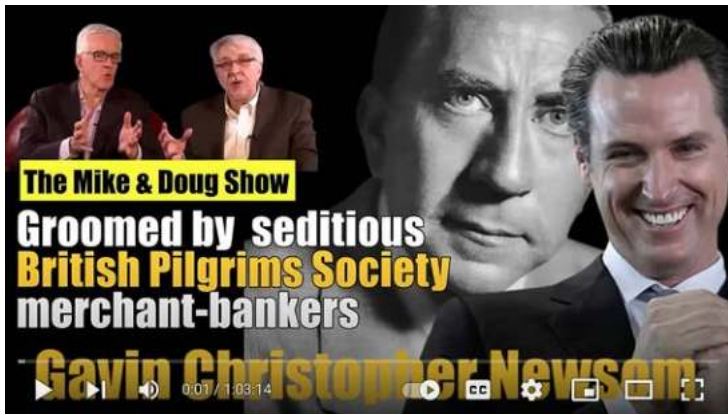


Fig. 4—Gabriel, McKibben. (Jul. 14, 2023). Gavin Newsom Groomed for the Presidency - British style. *Americans for Innovation, American Intelligence Media*. Source: [https://youtu.be/\\_GUIOC0IziQ](https://youtu.be/_GUIOC0IziQ) (Raw \*.mp4 video file).

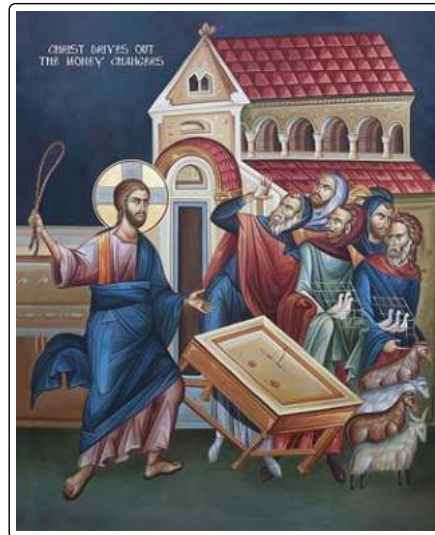


Fig. 8—Great and Holy Monday: “And Jesus entered the temple and drove out all who sold and bought in the temple, and he overturned the tables of the money-changers and the seats of those who sold pigeons. He said to them, It is written, ‘My house shall be called a house of prayer,’ but you make it a den of robbers.” [Matthew 21:12-13](#).

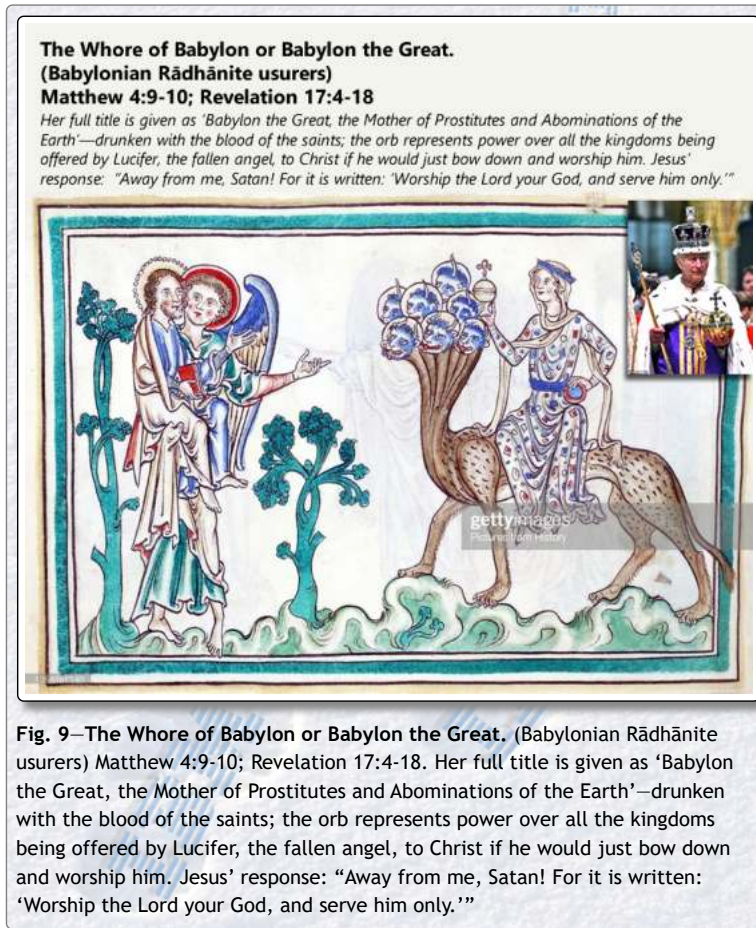

(The DC Bar subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)

The judges ignored [shocking new evidence](#) that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from Leader Technologies that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on *Leader v. Facebook* until justice is served, but we also welcome news and analysis of intellectual property abuse in other cases as well.

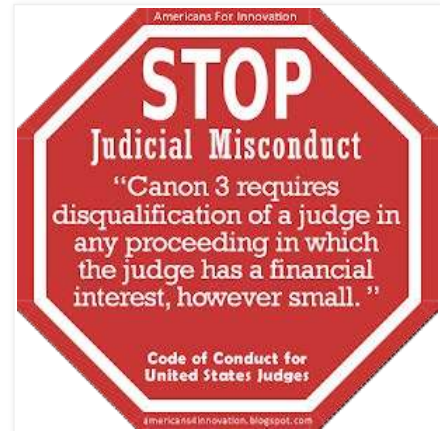

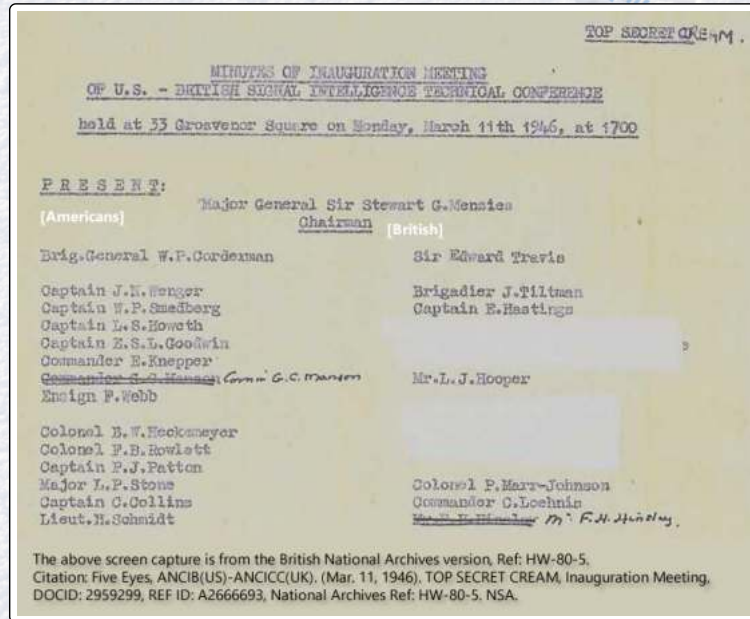


Fig. 10—[Five Eyes, ANCIB\(US\)-ANCICC\(UK\). \(Mar. 11, 1946\)](#). DAY 1: TOP SECRET CREAM, Inauguration Meeting, U.S. - British Signal Intelligence Technical Conference, March 11, 1946, DOCID: 2959299, REF ID: A2666693, National Archives Ref: HW-80-5, PDF p. 108. NSA.

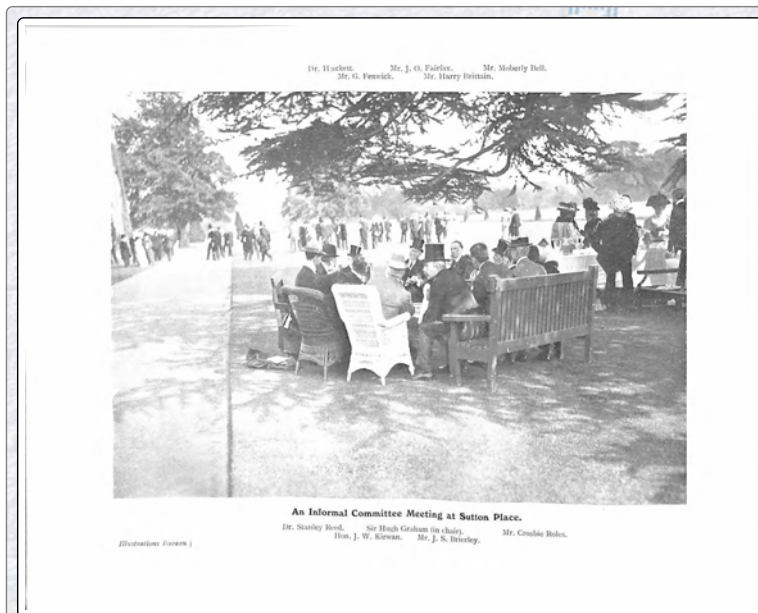


Fig. 11—Thomas H. Hardman, ed. pub. (Jun. 05-26, 1909) . A PARLIAMENT OF THE PRESS - THE FIRST IMPERIAL PRESS CONFERENCE, 1909, Illustrated, with Preface by The Earl of Rosebery, PDF p. 81. K.G. London: Horace Marshall & Son. [Transcript only](#). Reproduced for educational purposes only. Fair Use relied upon.

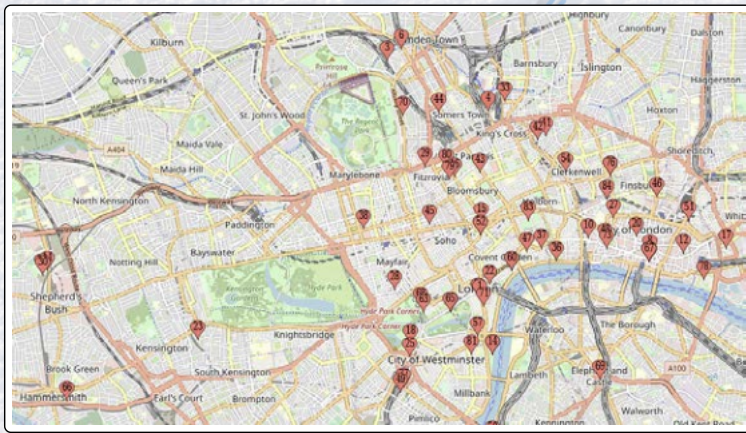
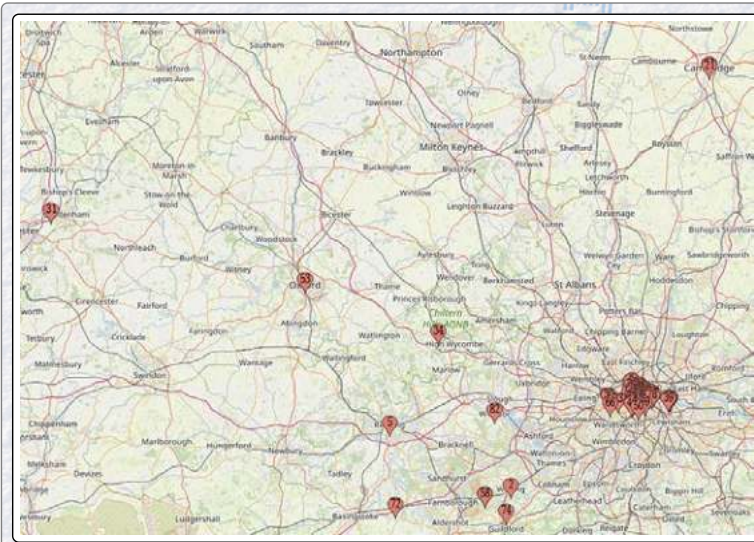


Fig. 12—Anonymous Patriots. (Jul. 10, 2023). UK DEMON MAMMON LAIRS. MapCustomer.com. Reproduced for educational purposes only. Fair Use relied upon. Source: <https://www.mapcustomizer.com/map/uk-demons>

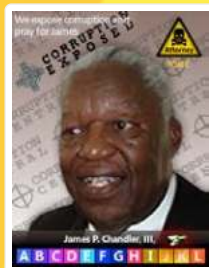
