


Fig. 5: Cyrus Ingerson ("C.I.") Scofield (1843-1921). "Scallywag" lawyer-politician-con artist turned evangelical Y.M.C.A. Bible commentator for the pagan Babylonian Rādhānite merchant-bankers of the Pilgrims Society in The City of London. (Hint: They are not Christian Plymouth Pilgrims, they are pagan Babylonian merchant-banker "pilgrims" who were forced to leave Babylon by the Seljuk Turks and move their Solomon's gold to The City of London in 1067 AD.) Scofield is the progenitor of "The Rapture," dispensationalism and British Christian Zionism. He has duped generations of evangelicals into silence, social passivity, and British political and economic debt slavery with their "Eretz Israel" British Pilgrims Society City of London merchant-banker scam.


Fig. 13--Baron Michael Farmer, the British Pilgrims Society, City of London

Tragically, Sarah Huckabee Sanders' handlers are the ones attempting to depopulate us folks.




Fig. 14--The Georgia Guidestones is a monument made in 1980 by an anonymous author that details in 8 different languages how to build a new society, with apparent advocacy of population control, eugenics, and internationalism. It was destroyed by an unknown person(s) on Jul. 27, 2022. See <https://youtu.be/X7CaQdN8bM8?si=M9cFBhOpB0BYQQDg>




