


Figure 2: Mayer Amschel Rothschild (1744-1812). Source: Prabook.

## Introduction: Exposing a Millennia-Old Deception

The Rothschild family, a persistent influence in global finance, has cast a pervasive reach over the economic and political landscapes of Europe, America, and beyond. Emerging from the shadows of 18th-century Frankfurt, their banking empire orchestrated wars, revolutions, and the creation of modern nation-states, leaving a legacy of moral decay in their pursuit of power. This essay unveils the Rothschilds' role in crafting British Zionism, weaponizing antisemitism as a shield, and controlling modern Israel through The City of London. It explores their strategic use of the Babylonian Talmud, Yiddish, and a false Jewish identity to undergird their merchant-banking agenda, the establishment of The City of London in 1067, and their perpetuation of power through the British aristocracy. From their shadowy founding of the Y.M.C.A. and the Salvation Army with JP Morgan, Cornelius Vanderbilt, Lord Rothschild of the Y.M.C.A. and the Salvation Army, both used to replace Black slaves with white, brown, and yellow ones, to their stranglehold on global financial systems, the Rothschilds have operated as the hidden hand behind humanity's darkest chapters, cloaked in a fabricated Jewish identity that has deceived nations for millennia.

# The Babylonian Rādhānites: Architects of Ancient Deceit

## From Kish to Babylon: Pioneers of Exploitation

The Rādhānites, documented by Ibn Khordadbeh in his *Book of Roads and Kingdoms* (ca. 870 AD), were a merchant-banking elite who dominated the Silk Road's commerce and banking, spanning from China in the east through Central Asia, the Middle East, Europe, North Africa, and Iceland. Their origins trace to Kish, a Mesopotamian city-state thriving between 5300–4300 BC, where they honed merchant-banking, usury, debt slavery, human trafficking, and ritual sacrifice. Cuneiform tablets from the Egibi and Murašû families (ca. 600 BC), housed at The Met, include 1,700 contracts detailing slave sales and debt agreements, exposing a sophisticated system of economic exploitation akin to modern banking.





Figure 4: The "Jewish" Houses of Egibis and Murašûs trafficked in slaves. Displayed above is a cuneiform tablet: agreement regarding disposition of slaves, Egibi archive ca. 540 BC. This contract is part of 1,700 tables of The House of Egibi Bankers from Babylon. *Source: The Met. See also AFI. (Apr. 19, 2023). The City of London Babylonian Merchant-Banker-Demon Hoax of all Time. Americans for Innovation.*

The Rādhānites, unlike Semitic Hebrews, were a diverse genetic blend of Silk Road peoples, including Turkic, Khazarian, Persian, Sogdian, Chinese, and Indian ancestry. A 2021 study in

Frontiers in Genetics identifies distinct genetic markers, such as a characteristic hooked-nose trait, confirming their non-Semitic origins.

In Revelation 2:9 and 3:9, St. John the Revelator denounced their deception, warning of “those who claim to be Jews but are not, forming a synagogue of Satan.” These passages, directed at Silk Road trading centers like Smyrna and Philadelphia, underscore the Rādhānites’ false Jewish identity—alleged as the first of the Rothschilds’ seven frauds—to gain trust among “People of the Book” while secretly venerating Mammon, Ba’al, Moloch, and other demon-gods. Within this framework, Khazarian merchant-bankers adopted a superficial conversion to Talmudic Judaism to perpetuate the Rādhānīte pretense of Jewish identity, reassuring their Silk Road clientele.




Figure 5: The Silk Road and Arab Sea Routes (11th - 12th Centuries). Source: Adapted from Jean-Paul Rodrigue, Department of Global Studies & Geography, Hofstra University who adapted it from Martin Jan Mansson. Used by permission.

The Khazar Empire, partly due to adoption of Judaism by its merchant-bankers, became a key northern route for the Silk Road as the Abbasids consolidated control over Baghdad to the south. ## Leveraging the Babylonian Talmud and Yiddish: Tools for Merchant-Banking

The Rādhānites strategically adopted the Babylonian Talmud and Yiddish as merchant-banking, cultural, and linguistic tools to bolster their false Jewish identity and advance their economic agenda. The Babylonian Talmud, compiled in Babylon from 70–500 AD following the destruction of the Second Temple, blended Babylonian paganism with Jewish oral traditions, creating a legalistic framework that diverged from the Torah's divine law. Its provisions on usury and social control, as seen in tractates like *Bava Metzia* (folios 61a–71b), provided a framework that the Rādhānites exploited to justify their merchant-banking practices, despite condemnation by Hebrew prophets (*Ezekiel 18:13*). Yiddish, a Germanic-Slavic hybrid with Turkic and Khazarian elements, emerged in the 9th–10th centuries among Rādhānīte communities in Europe. Unlike Hebrew,

Yiddish served as a secular tongue, enabling Rādhānites to conduct trade and banking across diverse regions while reinforcing their “Ashkenazi” façade.

This strategic adoption, necessitated by their 11th-century expulsion from Baghdad by Seljuk Turks, forced Rādhānites to fan out along their merchant-banking routes among European societies. By posing as “Ashkenazi” or “Sephardic” Jews, they masked their pagan Babylonian origins, using the Babylonian Talmud and Yiddish to maintain cohesion and deflect scrutiny. This deception, rooted in their control of Silk Road wealth—believed to include Solomon’s gold (amounting to more than 880 metric tons valued at over \$99 billion today, from the mines of Ophir, believed to be the location of the Rothschild-Rhodes DeBeers mine formed in the late 19th century)—enabled their integration into European aristocracies, setting the stage for their pervasive influence.

## **The Silk Road Empire: A Global Web of Control**

Centuries, if not millennia, before 800 AD, the Rādhānites dominated Rādhān, a prosperous Baghdad suburb, managing Silk Road settlement banks. Their influence stretched from China in the east through Central Asia, the Middle East, Europe, North Africa, and Iceland, driven by mastery of trade routes and financial instruments. Expelled from Baghdad, they fled to Europe with their wealth, adopting the “Ashkenazi Jew” identity to blend into Christian societies. This migration, facilitated by their control of Solomon’s gold, laid the groundwork for their modern incarnation as the Rothschilds, whose banking empire would perpetuate the Rādhānites’ ancient, morally compromised dominion, underpinned by their false Jewish identity.

## **The City of London: A Babylonian Stronghold Since 1067**

### **Founding The City of London: A Merchant-Banker Haven**

In 1067, the Babylonian Rādhānites first used their real name "Radknights" before soon changing their name to Ashkenazi Jews, a name that further distanced them from their pagan Babylonian merchant-banker ancestry, and secured a charter for The City of London, a square-mile financial enclave independent of royal oversight. Granted by William the Conqueror, this charter established The City as a hub for merchant-banking, insurance, commodities, and brokerage, mirroring Babylonian Rādhānite practices. The Domesday Book (1086), commissioned by William, inventoried England’s taxable assets, making multiple references to “Radknights” who conducted the business of landholders, including tax collection, enabling Rādhānite merchant-bankers to impose usurious loans and debt slavery, as they had in Babylon millennia earlier.

The City’s formation roughly coincided with the Rādhānites’ redirection of the Khazarian northern Silk Road routes through Central and Northern Europe, while redirecting the Anatolian routes through Smyrna with England’s navy. They financed the First Crusade (1096–1099), loaning money to knights to fight Seljuk Turks, who had seized Babylon (Baghdad) and Jerusalem. Ostensibly to liberate Jerusalem, this campaign aimed to reclaim Babylonian Rādhānite strongholds, with crusaders discovering the Holy Lance of Antioch, believed to secure victory from Antioch to Jerusalem. The City of London thus became a fortified base for Rādhānite wealth

and influence, perpetuating their worship of Mammon through merchant-banking, usury, debt slavery, and human trafficking.

## **Perpetuation Through the British Aristocracy**

The Rādhānites entrenched their power through intermarriage with the British aristocracy, ensuring The City of London's enduring dominance. By the 12th century, their wealth—bolstered by gold, silver, and trade monopolies—secured alliances with noble families, including the Plantagenets and Tudors. The Rothschilds, emerging in the 18th century, epitomized this strategy, falsely claiming British nobility as part of their seven frauds. Mayer Amschel Rothschild's sons married into European nobility, while Lord Rosebery, a maternal Rothschild, became a Pilgrims Society co-founder, linking The City to British and American elites.

The British aristocracy, seduced by Rādhānite wealth, perpetuated The City's tyranny through institutions like the Pilgrims Society (founded 1902). This cabal, convening in The City, orchestrated global intelligence (MI6, MI5, GCHQ), propaganda (Reuters, Associated Press), and biowarfare, ensuring aristocratic complicity in Rādhānite agendas. The 1909 Imperial Press Conference, led by Lord Rosebery, solidified media control, while aristocratic figures like David Lloyd George and Woodrow Wilson facilitated The City's annexation of American banking via the Federal Reserve Act (1913).

## **The Rothschild Ascendancy: From Frankfurt to Global Domination**

### **Mayer Amschel Rothschild: The Frankist Patriarch**

The Rothschild dynasty crystallized under Mayer Amschel Rothschild (1744–1812), a Frankfurt money-changer who brokered gold loans to the British Crown during the American Revolution. His ties to Jacob Frank (1726–1791), a Sabbatean-Frankist leader claiming messianic status, reveal the family's antinomian roots and their false religious piety, another of their seven frauds. Frank's teachings, advocating incest, pedophilia, and ritual murder as "sacraments," were endorsed by Mayer Amschel, who styled himself Baron of Offenbach. The Frankists, rejecting Jewish law for a Kabbalistic "higher Torah," believed the "elect" were exempt from moral constraints, a philosophy underpinning the Rothschilds' ruthless financial and social manipulations, leveraging their false Jewish identity to advance their merchant-banking agenda.

Mayer Amschel's five sons—Nathan, James, Salomon, Carl, and Amschel—established banking houses in London, Paris, Vienna, Naples, and Frankfurt, creating a pan-European financial network falsely presented as a beacon of financial stability. Their collaboration with Sir Moses Montefiore, Nathan's brother-in-law, facilitated stock market coups, notably after Napoleon's defeat at Waterloo (1815). By spreading false rumors of British defeat, Nathan manipulated the London Stock Exchange, amassing a fortune that cemented Rothschild dominance in The City of London, perpetuating their fraudulent financial narrative.

### **The Pilgrims Society: A Corporatist Imperial Agenda**

The Rothschilds' influence was amplified through their close involvement in the 1902 founding of the Pilgrims Society, a British-American aristocracy dedicated to reorienting the British Empire's economy from a monarchical colony state to a corporatist imperial state, with nefarious activities protected in perpetuity by the British Crown under the Pilgrims' control. While the Rothschilds did not control the Society's formation, they were top-tier players, providing substantial funding and political support, acting as dutiful taskmasters for the Pilgrims Society aristocracy, of which they

were a prominent part. This agenda aimed to consolidate global power through corporate monopolies, intelligence networks (MI6, MI5, GCHQ), propaganda (Reuters, Associated Press), and biowarfare, ensuring the Rothschilds' merchant-banking interests aligned with the broader imperial vision.

Lord Rosebery, a maternal Rothschild, led the 1909 Imperial Press Conference, establishing the Empire Press Union to control global narratives. The Society's American branch, including Lyndon Johnson, Richard Nixon's cabinet (Kissinger, Volcker, Haig), and Walter Cronkite, extended Rothschild influence over U.S. politics and culture, undermining the American Republic as planned in 1908, as uncovered by journalist Lillian Scott Troy. The Pilgrims Society's corporatist framework, with the Rothschilds as key financiers, entrenched their false financial stability narrative within a larger imperial strategy.

## British Zionism: A Rothschild Masterstroke


### The Balfour Declaration: A Zionist Facade

The Rothschilds' fingerprints are indelible on modern Israel's creation, orchestrated through The City of London and the Pilgrims Society, embodying their false Palestinian Zionism fraud. The 1917 Balfour Declaration, addressed to Lord Walter Rothschild by Prime Minister Lord Arthur Balfour, endorsed a Jewish homeland in Palestine, aligning with British imperial ambitions to control the Middle East. Baron Edmond de Rothschild funded early Zionist settlements like Rishon-LeZion (1882) and Petah Tikva (1883), donating 500,000 francs annually to Eastern Jewry via the Alliance Israélite Universelle, falsely portrayed as philanthropy. Sir Moses Montefiore established Mishkenot Sha'ananim (1860), the first Jewish settlement in what became Israel, leveraging their false Jewish identity to advance their merchant-banking interests.

The Balfour Declaration masked British geopolitical goals—securing Jewish support in World War I—while advancing Rothschild ambitions to dominate Palestine. Benjamin Disraeli, a British Prime Minister of Jewish descent (1868, 1874–1880), endorsed this narrative, describing London as “a modern Babylon” in *Tancred* (1847). Sir Alfred Mond, a Pilgrims co-founder and head of Brunner-Mond (later AstraZeneca), bolstered British military supremacy through biowarfare and gunpowder production, consolidating Rothschild influence within the Pilgrims’ imperial framework.




**Figure 13: Alfred Moritz Mond, 1st Baron Melchett, PC, FRS, DL (23 October 1868 – 27 December 1930), known as Sir Alfred Mond, Bt between 1910 and 1928, was a British industrialist, financier and politician. In his later life he became an active Zionist. Photo: Public domain.**

## Manipulating Evangelicals: The Scofield Deception

The Rothschilds funded Cyrus Scofield, a controversial figure with a fraudulent past, to create a Bible Commentary published by Oxford University Press. This work molded evangelical views on End Times prophecy, promoting “The Rapture,” dispensationalism, and Christian Zionism. It

convinced American Christians to support British Zionism and the Rothschild-backed purchase of Palestine, diverging from traditional Christian teaching that the Church, fulfilled in Jesus Christ, is the new Israel (*Revelation 17:5*). Mike Huckabee, U.S. ambassador to Israel and a former Baptist minister, reflects this dispensationalist influence, underscoring the Rothschilds' enduring propaganda and false religious piety.

## Antisemitism: A Rothschild Weapon

### The Frankist Legacy: Deflecting Criticism

The Rothschilds wielded accusations of antisemitism to deflect criticism of their immoral practices, leveraging their false Jewish identity. Their ties to Jacob Frank's Sabbatean-Frankist debauchery, embracing Satanism, provoked outrage among Jewish communities. When criticized, the Rothschilds cried "antisemitism," a tactic rooted in their Babylonian imposture, reinforced by their strategic use of the Babylonian Talmud and Yiddish to align with their merchant-banking agenda. Maurice H. Halperin, named in recently released JFK files, collaborated with the UN's Hebrew language service to promote Zionist migration, using antisemitism to conceal the Rothschilds' pagan origins. Lord Victor Rothschild's 1973 order to falsify the family name as "BACHARACH" hid their Khazarian roots, perpetuating their fraudulent identity.

### The ADL: Guardians of the Smokescreen

The Anti-Defamation League (ADL), founded in 1913, serves as a Rothschild tool to perpetuate the antisemitic shield. With a reported \$238 million in assets (2021), far exceeding its parent B'nai B'rith's \$6 million, the ADL's wealth suggests ties to banking, drugs, or human trafficking. Its leadership, accused of hiding Babylonian Rādhānīte identities, uses Jewish identity to deflect scrutiny of usury and power grabs, aligning with The City of London's merchant-bankers. The ADL's simultaneous founding with the Federal Reserve underscores its role in protecting Rothschild financial interests, reinforcing their false financial stability narrative.

## Control over Modern Israel: A Rothschild Stranglehold

### Financial Dominance: The City of London's Reach

The Rothschilds exert influence over Israel through The City of London. Banks like JPMorgan and asset managers like BlackRock, shaped by Rothschild wealth, dictate Israel's economy. Their 2014 acquisition of Thomson Reuters' "Know Your Customer" database enables financial surveillance tied to Social Credit Scores and Carbon Credits. The London Bullion Market, managing historical gold, impacts Israel's financial stability. Petah Tikva, home to TeleMessage—a compromised White House text system—honors Edmond de Rothschild's Zionist legacy, perpetuating their false philanthropy.

### Biowarfare and Global Ambitions

The Rothschilds' involvement in the Pirbright Institute's U.S. Patent No. 10,130,701 (Coronavirus, 2018), backed by GlaxoSmithKline, Bill Gates, and DARPA, signals a biowarfare agenda, contradicting their false biotechnology leadership. Dame Stella Rimington, former MI5 chief and Wellcome Trust governor, ties Rothschild Asset Management to this scheme. The Pilgrims Society's control of MI6, MI5, GCHQ, and media outlets ensures Rothschild narratives align Israel with British-American interests, advancing the corporatist imperial state.

## The Y.M.C.A. and Salvation Army: Rothschild Tools for Urban Slavery

### A Corruptive Founding




Figure 18: Sir George Williams was MP Boris Johnson's great, great, great grandfather that he never talks about in any of his biographies. Co-founders of the YMCA include Cornelius Vanderbilt, Elihu Root, Barclays Bank, JP Morgan allied with the Rothschilds—all bankers with a high need to replace their black slaves globally with increasingly industrial white, brown, and yellow debt slaves. *Source: YMCA, public domain.*

# Blue chip genes promise high returns

"OUR INTENTION is to seek a much higher than average return on the unquoted part of your portfolio within three to seven-year time-scale," Lord Rothschild says in the second annual report of Biotechnology Investments. His report suggests that it is making good progress—indeed, it reads like a catalogue of the "blue chip" end of the spectrum of new biotechnology companies which have blossomed in the past few years.

**Increase**

With two-thirds of the \$1m fund now invested, almost equally in quoted and unquoted biotechnology companies, it is showing a 25 per cent annual net asset value per share on the year, and 35 per cent over two years.

Biotechnology Investments, set up on the initiative of Lord Rothschild, as an offshoot of N.M. Rothschild Asset Management, now has a portfolio of 31 investments, both big and very small. All unquoted companies must still meet the strict criteria laid down by the directors. Lord Rothschild summarises the five rules as follows:

- It must employ not only scientists of high calibre but also first-rate business managers, so that the team is "ready and able to establish a successful venture."
- Its business plan should clearly define its research and product areas, and contain both a market analysis and a realistic assessment of the competition.
- Its potential rate of return must be in line with the risk being taken.
- It must have a sponsor to act as lead investor and to accept responsibility for the venture. (Although the fund itself has been known to act in this role.)
- The company must have plans for releasing the investment normally through a public share issue.

In the year ending May 31, the fund received 92 investment proposals, of which 57 came from the U.S., compared with 16 from Britain, three from Israel and one apiece from Belgium, Canada, Finland, France, West Germany and British biotechnology investments.

Of those, it chose three U.S. companies in which to invest: Cetus, where the \$1m invested will go mainly to support the use of enzymes in petrochemical processes; CW Ventures, a fund which invests in health care; and Immuno, a company with close links to Hoffman-La Roche and high hopes of leading the field with a treatment for AIDS (auto-immune deficiency syndrome).

**Change**

By this summer the scene had changed dramatically. No fewer than four of the fund's investments have gone public, in each case advantageously: Amgen, Applied Biosystems, Integrated Genetics, and Immunogen. (Indeed, Mr David Leathers, investment manager, says that the fund has an intention of selling companies which go public, but will still continue to apply the five rules by which they judged the original investment. Even so, he admits that the fund it did not expect so many of its unquoted investments to go public so soon.)

Another dramatic change is the view the fund takes of

France, West Germany and British biotechnology investments. In the past Lord Rothschild has been forthright in expressing disappointment with the caliber of companies coming forward with investment proposals. Other London finance houses have suggested that they see the need for a more creative approach in Britain, to produce packages appropriate to a situation, rather than passively awaiting a proposal as Biotechnology Investments has tended to do in the U.K.

During the year the fund made its first-ever investment in an unquoted British company. It is also its biggest investment in this sector. The fund has £3.1m in Celltech, the company with an inside track to the

company is able not just to make scientific discoveries but to scale-up, extract, purify, and market its products, as evidenced by its first product, the anti-interferon monoclonal antibody.

The current position, according to David Leathers, is that the fund is evaluating half-a-dozen British companies in which it has no new ones "on the front burner" from the U.S. It is, however, considering the investment of another \$1m in Repligen, one of its first investments, which now needs more cash to help build a pilot fermentation plant.

**Coy**

Of the British prospects, the fund is coy for the moment. One that interests them is the Agricultural Genetics Company, set up this summer as a "quasi-public" company, to try to exploit the plant genetics research of the Agricultural Research Council.

As Biotechnology Investments see it, the new company has been very modestly funded by its three partners—British Technology Group, Advent and Ultramar—at the outset, until the investors see the first busi-

ness plan. Then the partners and other investors will be invited to plough more heavily.

Two of the funds older U.S. investments, Genetic Systems and Applied Biosystems, have just announced a joint venture in immunodiagnostics, to develop two new diagnostic systems, one simple and inexpensive for "doctor" surgeries; the other automated for clinics and hospitals.

These systems are aimed at the diagnosis of bacterial and viral infections, chronic illness, and cancer, cardio-vascular and genetic disease. Round at Rothschilds, they see the move as an important one for both companies.

In further recent investment which excites the fund managers is the \$1m they have ploughed into Genzyme, a U.S. company set up to acquire Whatman Biochemicals in Britain. This company makes diagnostic enzymes. It has since bought Koch-Light Laboratories, another British company, making fine chemicals.

Genzyme's plan is to use these two UK companies as a base for developing biotechnology interests. Biotechnology Investments see the company as virtually British but driven by American entrepreneurial initiative.
