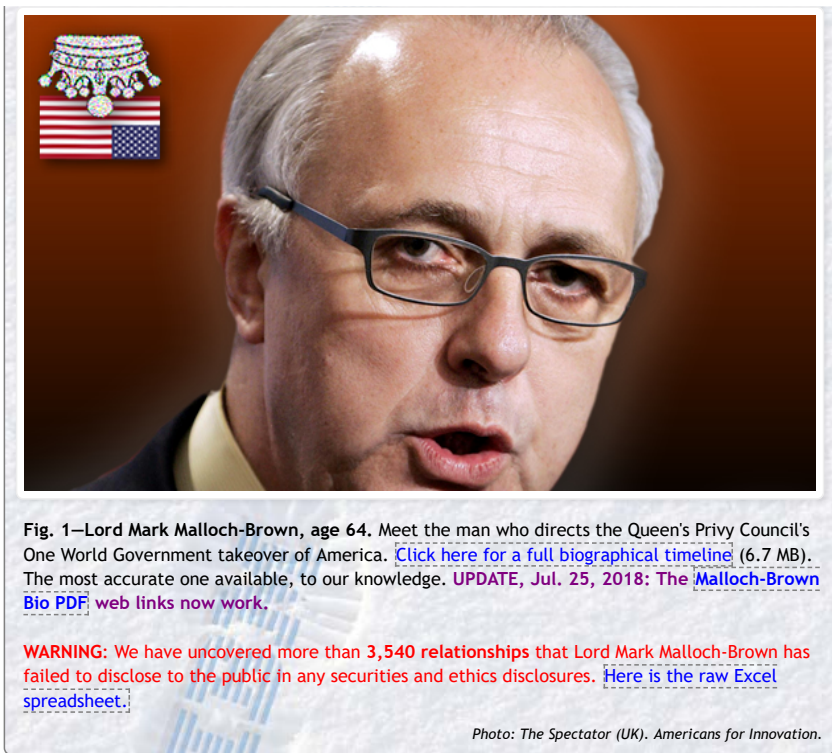

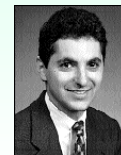

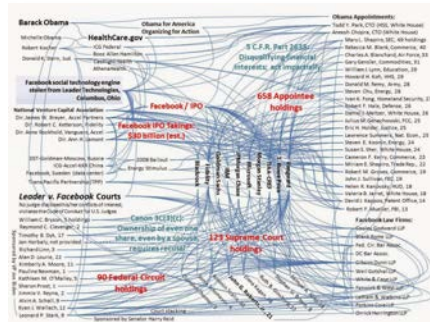

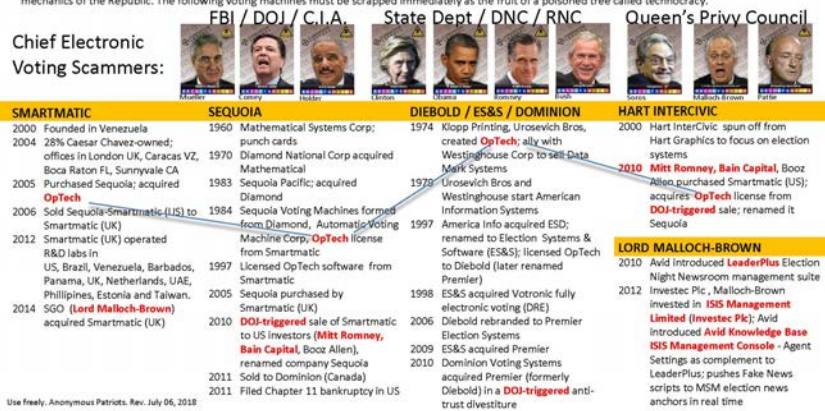


Fig. 5—Scrap Electronic Voting Machines NOW! (PDF).

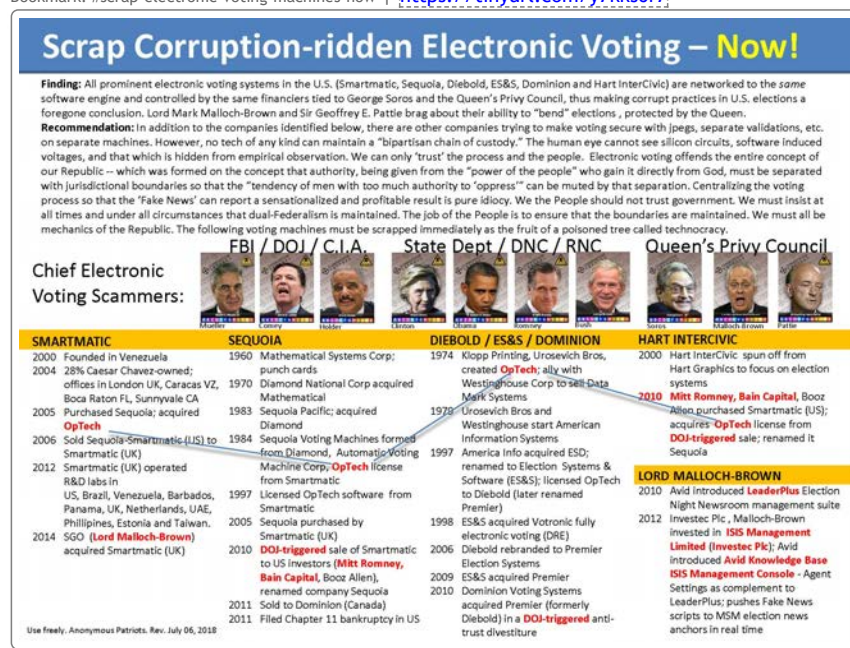


Fig. 5—Scrap Electronic Voting Machines NOW! (PDF).

We interviewed those who spoke English and were told that for \$40K, anyone can catch a ride to the United States on a ship nobody would ever suspect." Immigration was immediately called and found that of the 460 people on board illegally, not one had been through any kind of vetting process. After running the men through facial recognition, they found more than a dozen suspected terrorists who are on the US no-fly list. Those men were about to be unleashed on the public for \$40K each.

The indictment, obtained by Fox News, alleges the group made up Raniere's "inner circle" and helped him with various illicit activities such as conspiracy to commit crimes like identity theft, harboring of aliens for financial gain, extortion, forced labor, sex trafficking, money laundering, wire fraud and obstruction of justice. - READ MORE
