No longer a mere nominee, Blanche now wields unchecked power, his sanitized Senate questionnaire (detailing a J.D. from Brooklyn Law in 2003, SDNY prosecutor from 2006–2014, and stints at WilmerHale and Cadwalader) masking a venomous nest of undisclosed interlocks. Susie Wiles' rise from Reagan '80 operative to Trump's 2024 architect masks a voracious appetite for mining spoils, undisclosed and unethical, funneling Trump's deregulations into foreign coffers. *Betrayal of Trust* unmasks her: \$180,000 in 2019 fees lobbying for Pebble Mine—a Bristol Bay destroyer under Northern Dynasty Minerals and Barrick Gold—despite EPA vetoes. Executive Order 14241 (March 20, 2025) revived it, boosting Barrick 15% and enriching her web: BlackRock (\$1.06B stake), Vanguard, and George H.W. The nexus? Baron Michael Stahel Farmer, Lord Farmer of Bishopsgate—"Mr. Copper"—whose five-decade reign over London's metals via RK Capital and the London Metal Exchange (LME) dovetails Barrick's gold-copper veins. Farmer's roots—pseudo-Jewish merchant-bankers owning Metallgesellschaft AG—interlocked with Rothschild Frankfurt vaults for silver, copper, and gold trades worth billions. Farmer's Pilgrims Society membership (founded 1902 for Anglo-American "annexation") extends tentacles into U.S. conservative circles: He financed Turning Point UK (TP UK), the British arm of Charlie Kirk's Turning Point USA, with his son George Farmer—the baron-in-waiting—as its former CEO and chairman. George sealed the dynasty by marrying Candace Owens in 2019, an unlikely pairing, blending Farmer's mining millions with Owens' *Daily Wire* megaphone and Kirk's youth mobilization machine—a transatlantic trojan horse funneling British influence into MAGA ranks under the guise of "America First."
